

EUMICON Membership Agreement

1. Introduction:

This Membership Agreement ("Agreement") sets out the terms and conditions governing membership with EUMICON ("the Association"). By becoming a member, you agree to abide by these terms and conditions

2. Membership categories:

EUMICON offers the following categories of membership:

- Strategic Leaders or Members: Producer companies in the raw materials and metals value chain (mining, refining, smelting, metal transformation, battery materials, recycling)
- Supporting Members: Any other key industry stakeholders involved in the metals and raw materials value chain, such as suppliers, consultants, academic institutions, and non-governmental organisations (NGOs)

3. Application and admission:

- Prospective members must submit a completed application form, along with any required supporting documentation
- The Board of Directors reserves the right to review and approve applications based on the applicant's alignment with EUMICON's objectives

4. Membership fees:

- Membership fees are determined annually and must be paid within 30 days of invoicing
- Failure to pay within the prescribed period may result in suspension or termination of membership

5. Rights and obligations of members:

- Members have the right and access to participate in EUMICON events, access publications, and engage in networking opportunities according to their membership and the availability granted by the association
- Members must uphold EUMICON's statutes, contribute to its initiatives, and ensure timely payment of fees

6. Code of conduct:

- Members must conduct themselves with integrity, professionalism, and transparency in all association-related activities
- Compliance with applicable laws, including competition law, is mandatory

7. Governance:

- The General Assembly, composed of all members, meets annually to discuss and vote on key decisions.
- The Board of Directors is responsible for strategic oversight and management of the Association's affairs.



8. Termination of membership:

- Members may voluntarily resign by providing written notice at least 60 days prior to the renewal date
- Membership may be terminated due to non-compliance with obligations, non-payment of fees, or actions contrary to EUMICON's interests

9. Liability and indemnification:

- EUMICON shall not be liable for any losses or damages incurred by members in connection with their participation in the Association
- Members agree to indemnify EUMICON against any claims arising from their activities within the Association

10. Dispute resolution:

- Members are encouraged to resolve disputes amicably through internal mediation processes
- Unresolved disputes shall be subject to the jurisdiction of the courts of Belgium, unless otherwise agreed

11. Amendments to Terms & Conditions:

- Amendments to this Agreement may be proposed by the Board of Directors or members and must be approved by a majority vote at the General Assembly

12. Data Protection & Privacy:

- EUMICON is committed to complying with the General Data Protection Regulation (GDPR) in handling member data
- Personal data shall only be used for the purposes outlined in EUMICON's Privacy Policy

13. Miscellaneous provisions:

- Intellectual property created within the Association's framework remains the property of EUMICON unless otherwise agreed
- Members must seek prior approval before publicly representing EUMICON or using its branding
